

## **Quick Summary & Statistics**

- According to the AG's most recent 2023 report, Linda Singer (D.C. Attorney with Motley Rice LLC) and Charles R. Webb (Charleston Attorney with the Webb Law Center) received \$36,205,050.00 in attorneys' fees in 2023. Inconsistently, the Commissioner of the *In re Opioid* Common Benefit Fund recommended Motley Rice and Webb Law Centre receive \$41,655,050.00 of the attorney fee fund.<sup>1</sup> This award constitutes more than 50 times the recovery of most other recipients and more than double that of all fund recipients.
- Troy N. Giatras of the Giatras Law Firm, PLLC, and Jesse Forbes of Forbes Law Office, PLLC, currently handle five cases on a contingency fee arrangement as outside counsel.
  - Troy N. Giatras, now practicing solo at the Troy Law Firm, will receive \$25,000 from the *In re Opioid* attorney fee fund.
  - Jesse Forbes will receive \$15,000 from the *In re Opioid* attorney fee fund.
- Paul T. Farrell, formerly based in Huntington, West Virginia, received part of a \$4,666,436.09 attorney fee award from his appointment under then-Attorney General Darrell McGraw in *GlaxoSmithKline* (2014). Now, Farrell practices in San Juan, Puerto Rico at Farrell & Fuller. Under the *In re Opoid* attorney fee fund, Powell Farrell/Fuller and Powell & Majestro stand to receive \$20,150,000.00 combined.
- In 2015, Charleston-based attorneys Lee Javins and Taylor M. Norman of Bailey Javins & Carter LC received an estimated \$4.85 million in attorney fees from their appointment in the *Mckesson* opioid litigation.
- The Law Firm of DiTrapano, Barrett, & DiPiero, PLLC received attorney fee awards over approximately \$2 million for their work on the *AmerisourceBergen & Purdue* cases.
- Over the past decade, most of the AG reports lack the transparency required by West Virginia Code §5-3-4. Morrisey appointed outside counsel in several matters identified below, but many AG reports fail to provide the attorneys' names or the attorney fees paid for such engagements, as is required under state law.<sup>2</sup>
- In total, we have identified approximately thirty-one (31) outside counsel representations that have either been reported, or should have been reported in accordance with W.Va. Code § 5-3-4 during Attorney General Morrisey's tenure of 2013-2023.<sup>3</sup>
- Outside counsel serving during this 10-year period have received nearly \$53 million in identified attorneys fees, with a number of awards yet to be identified.

## AG Reporting Requirements on Outside Counsel Arrangements

Under WV Code § 5-3-4(a), the Attorney General ("AG") shall, annually on or before November 1, deliver to the Governor, President of the Senate, and Speaker of the House an annual report detailing the "state and condition" of the several causes of action in which the state is a party. W. VA. CODE § 5-3-4(a). In pertinent part, § 5-3-4(a)(2) requires the Attorney General to provide in the report, "[t]he use of any fee arrangements as provided in subsection (h), section three-a of this article with private attorneys in the preceding year." *Id.* at § 5-3-4(a)(2).

Further, § 5-3-4(2)(A)(i)—(v) requires AG reports to include the following information on outside counsel: (i) The name of the private attorney with whom the state has contracted, including the name of the attorney's law firm; (ii) The nature and status of the legal matter; (iii) The name of the parties to the legal matter; (iv) The amount of the recovery; and (v) The amount of any legal fees paid. *Id.* at § 5-3-4(2)(A) (v) (emphasis added).<sup>4</sup> Unfortunately, only AG reports from 2013, 2014, and 2023 identify the legal fees paid to outside counsel. In 2013 and 2014, AG reports failed to identify the name or law firm of counsel retained. Despite our findings that Morrisey made such arrangements, AG reports do not identify civil cases where the AG's office appointed outside counsel in 2015, 2016, 2017, 2018, 2019, and 2020. The 2016 and 2017 reports merely identify outside counsel for Division of Corrections cases.

In 2021 and 2022, AG reports do identify cases handled by outside counsel. In the 2021 report, six *In re Opioid* cases identified Joseph Rice and Linda Singer of Motley Rice LLC and Charles R. Webb of The Webb Law Centre as outside counsel. In the 2022 Report, outside counsel additions included Troy Giatras of the Giatras Law Firm, PLLC, Jessee Forbes of Forbes Law Office, PLLC, and Robert M. Bastress III of DiPiero Simmons McGinley & Bastress, PLLC. Finally, the 2023 AG report, issued on November 1, 2023, identifies four additional cases that Troy Giatras and Jesse Forbes are currently handling.

Overall, the AG reports largely fail to comply with WV Code § 5-3-4. Nonetheless, we have identified the following outside counsel, including some awards of attorney fees.

# Outside Counsel Identified Through AG Requests for Proposals

- AG Request for outside counsel proposals #26<sup>5</sup>
  - July 28, 2014, "seeking assistance in the bankruptcy matter filed by Freedom Industries which is currently pending in the Southern District of West Virginia."
  - On July 30, 2014, Cambell Woods, PLLC, a Charleston based firm, appointed as outside counsel.<sup>6</sup>
- AG Request for outside counsel proposals #367
  - July 22, 2015, seeking the assistance of outside counsel to "facilitate the recognition and collection, in the State of California, a judgment obtained pursuant to the West Virginia Consumer Credit and Protection Act. More specifically, the WVAGO is seeking legal assistance to obtain recognition, in the State of California, of a judgment that has been obtained against CashCall, Inc. in order for WVAGO to collect on that judgment."
  - On September 03, 2015, Pettit Kohn Ingrassia & Lutz were appointed. Both are attorneys based in San Diego, California.<sup>8</sup>

### In re Opioid Outside Counsel & Attorney Fee Awards

On September 21, 2023, the Common Benefit Fund Commissioner issued recommendations regarding attorney fees and expenses related to the Opioid Litigation and Resulting Settlements. *In re Opoid Litigation*, COMMON BENEFIT FUND COMMISSIONER'S RECOMMENDATIONS REGARDING ATTORNEY FEES AND EXPENSES, 1 (Sept. 21, 2023). As reported in the AG's 2022 report, Motley Rice (and Webb Law Centre) served as lead counsel in the Manufacturer and Pharmacy cases in its capacity as the Attorney General's outside "special counsel." *Id.* at 21. The following passage from the Commissioner's recommendations describes their distribution:

Motley Rice agreed to perform all needed legal services on a contingency fee basis capped at 14% of the first \$20 Million recovered and thereafter in accordance with subsection I of the Attorney General's Policy on Outside Counsel, which provides for: ten percent (10%) of any portion of the recovery between \$20 million and \$25 million; plus five percent (5%) of any portion of the recovery exceeding \$25 million. Webb Law Centre was also appointed as special outside counsel pursuant to the Written Determinations and agreed to the above terms. Applying this formula to each of the Manufacturer and Pharmacy settlements in this litigation, the Commissioner recommends that Motely Rice and Webb Law Centre **receive an aggregate contingency fee in this case of \$41,655,050.00** from the 72.5% portion of the Attorney Fee Fund.

*Id.* at 22. The Commissioner's recommendations further provide under W. Va. Code § 5-3-3A(h), the aggregate total of Motley Rice's and Webb Law Centre's total attorney fees across this litigation is capped at \$50 Million as it arises from a single event or occurrence. *Id.* at 22-23. Thus, neither Motley Rice nor Webb Law Centre will receive fees from the common benefit fund. *Id.* at 23.

The Commissioner recommended distributions from the common benefit funds as follows: (1) Allen, Chesson & Grimes (Anna Majestro): \$50,000.00; (2) Chafin Law Firm: \$850,000.00; (3) Farrell Fuller / Powell Majestro: \$20,150,000.00; (4) Fitzsimmons Law Firm: \$22,500,000.00; (5) Forbes Law Firm: \$15,000.00; (6) George & Lorenson: \$25,000.00; (7) Harry Bell: \$25,000.00; (8) Harris & Holmes: \$1,000,000.00; (9) Irpino, Avin & Hawkins: \$2,000,000.00; (10) Linkous Law: \$1,850,000.00; (11) Lisa Ford: \$46,927.50; (12) Mullens & Mullens: \$100,000.00; (13) Morgan & Morgan: \$500,000.00; (14) Napoli Shkolnik: \$1,250,000.00; (15) Robert L. On October 9th, at 2:33 P.M., Judge Allen D. Moats entered an *Order Approving Common Benefit Fund Commissioner's Recommendations Regarding Attorney Fees and Expenses*.

### AG Office's Late Objection to Attorney Fees

On October 9, 2023, at 4:40 PM, Deputy Attorney Generals Ann L. Haight, Laurel K. Lackey, and Abby G. Cunningham filed the *Office of the West Virginia Attorney General's Objections to the Order Approving the Common Benefit Fund Commissioner's Recommendations Regarding Attorney Fees and Expenses*, just two hours after Judge Moats Order of approval.<sup>9</sup> In its objections, the AG's Office argues the recommended 15% of gross settlements for aggregate attorney fees are excessive in light of additional proceeds that some recipients received in earlier settlements with the opioid distributors. The Office shed light on the settlement with McKesson, AmerisourceBergen, and Cardinal for \$400,000,000. According to the AG office's objections, "[t] his amount does not include the additional MDL assessment of 7.5% of the \$400 million aggregate settlement reached with the distributors. Taken together, the real amount being paid in fees and costs for this litigation becomes \$171,057,900." Thus, distributor settlement attorney fees for the "Big Three" (AmerisourceBergen, Cardinal Health, and McKesson) were approximately \$30,000,000, although entirely unreported. On October 11, 2023, Judge Moats and Judge Swope "f[ound] the objections to be without merit" and denied them.<sup>10</sup>

### Morrisey's "At-Glance" "Definitive Chart" Decoded and Debunked

On January 4, 2024, AG Patrick Morrisey published a "Definitive Chart Showing Dramatically Lower Outside Counsel Fees Under General Patrick Morrisey" to accompany an article responding to WV CALA's research efforts to provide transparency the citizens of West Virginia deserve.<sup>11</sup> Nonetheless, Morrisey's "at-glance" "definitive chart" lacks important details that are necessary to fully vet his claims. His chart identifies cryptic case captions, listing just shorthand names of the defendant companies without identifying civil action numbers or the outside counsel appointed for such matters, which are similarly absent from the AG's annual reports to the Governor. Morrisey's cryptic chart misreads readers to believe multiple entries constitute different cases with different outside counsel. However, as identified in a snapshot of Morrisey's chart below, we believe the following entries constitute the same case, with presumably the same outside counsel.

Accordingly, identified outside counsel Guy Bucci, Timothy Bailey, L. Lee Javins, II, William Druckman (Charleston, West Virginia-based attorneys), and Laura J. Baughman and S. Ann Saucer (Dallas, Texas-based attorneys) presumably received all attorney fees for *State of West Virginia ex rel. Patrick Morrisey v. Bank of America N.A.* and *State of West Virginia ex rel. Patrick Morrisey, Attorney General v. Bank of America Corporation, et al.*, including: \$487,000 (Bank of America Credit Cards); \$487,000 (Chase); \$487,000 (Citigroup); \$487,000.00 (G.E. Money Bank); \$487,000 (Discover); \$487,000 (HSBC); \$21,667.00 (WFNB). In total, outside counsel on the Bank of America (Credit Cards) litigation received \$2,943,667.67 in addition to attorney fees from First Premier Bank for \$112,500 (identified as a case handled by McGraw). *This amount constitutes approximately 24.4% of the overall award.* 

As to *State of West Virginia ex rel. Patrick Morrisey v. Bank of America N.A.*, identified outside counsel Joshua Barrett and Sean McGinley of the law firm DiTrapano Barrett & DiPiero and Robert V. Berthold, former attorney for Tiano & O'Dell now practicing solo, received all attorney fees for the matter, including: (1) \$17,500.00 (Municipal Derivatives George K. Baum); (2) \$87,500.00 (Municipal Derivatives Bayerische Landensbank; (3) \$237,500.00 (G.E. Money Bonds); and (4) \$300,000.00 (Bank of America Municipal Derivatives). Thus, in sum, outside counsel received a total of \$642,500 in attorney fees. *This constitutes approximately 23% of the overall award.* 

Moreover, Morrisey's own 2014 report identifies he handled settlements with JP Morgan and Morgan Stanley, yet Morrisey claims these cases were handled by McGraw alone in his "Determinative Chart."

In 2014, settlements were reached with J.P. Morgan in the amount of

\$400,000.00; Morgan Stanley in the amount of \$150,000.00; and G.E. Funding in the

amount of \$950,000.00. Discovery continues with respect to the remaining Defendants.

As a whole, Patrick Morrisey's "Determinative Chart" *fails to provide a full picture of the nearly \$68.5 million dollars in outside attorney fees* the Attorney General's Office has paid out over Patrick Morrisey's ten-year tenure, with multiple awards remaining to be unveiled. This total nearly *triples* the *\$28 million dollars* Morrisey identifies were paid out under McGraw in the chart he published.
